## TransportSimple PRIVACY POLICY

#### 1. BACKGROUND

- 1.1. TransportSimple ("Product"), www.transportsimple.com ("Website") and Employee App | TransportSimple (Application) is owned, registered and operated by M/s. Indersons Services Private Limited ("Company"), a company incorporated under the relevant provisions of the Companies Act, 2013. The Company through its Product provides Vehicle data management and tracking services ("Services").
- 1.2. For the purpose of this Privacy Policy, wherever the context so requires 'You', 'Your', or 'User' shall mean any natural person who uses the Product for availing the Services. The term "Company", "We", "Us", "Our" shall mean the Company, its employees, and authorised agents that perform any services on the Company's behalf.
- 1.3. By using the Product, You consent to the manner of usage, collection, storage and sharing of information collected from You as provided for in this Privacy Policy.
- 1.4. This Privacy Policy covers:
  - i. the type of information collected from You through the Product, including sensitive personal data or information;
  - ii. the purpose, means and modes of usage of such information; and
  - iii. how and to whom such information which has been collected will be disclosed.
- 1.5. We reserve the right to make changes to this Privacy Policy at any time. Any such modifications will become effective immediately upon posting to the Website and Your continued use of the Website, the Product constitutes Your agreement to such modifications. #### 2. INFORMATION COLLECTED FROM THE USER

- 2.1. Personal Information: For the purpose providing Services, Company collects the following personally identifying information ("Information") from the Users during their use of the Website, the Product or the Application:

#### 3. HOW THE COLLECTED INFORMATION WILL BE USED

- 3.1. The Information collected by the Company, shall be used for the purposes and in the manner described below:
  - i. **Registered user name and password:** The registered user name provided to the User shall be used to access the Product and to personalize all communications that are sent to the User by the Company;
  - ii. **E-mail Address:** Your E-mail address will be used for all communication from the Company, to You, in relation to the usage of Product by User;
  - iii. **Phone Number:** Phone number will be an alternative method to contact the User for any matter related to the usage of the Product by the User;
  - iv. **Address:** Your address will be an alternative method to contact the User for any matter related to the usage of the Product by the User;
  - v. **Credit/Debit Card or UPI information:** Credit/Debit Card or UPI information is used for charging the User for any transaction related to the usage of the Product;
  - vi. **Billing and Transaction information:** The Company would store the billing and transaction information of the Users for record-keeping, and maintenance of its accounts.
  - vii. Employee App | TransportSimple application's location: The company would store and share this location with the user to track user's vehicle without the need of any external GPS devices, this also allows us to automate the distance travelled by the vehicle
  - viii. In order to improve the quality of our Services provided to You, we may ask You to provide Us with information regarding Your experiences with the usage of our Website, the Product or the Application.
  - ix. We may use Your information to send You promotional information pertaining to the Product.
  - x. We reserve the right to ask You, at the time of availing subscription for availing the Product or thereafter, for documentary proof of Your identity or other data or postings provided by You with usage of the Product. In the event that You fail to provide Us with this information or documentary proof, We reserve the right to refuse Your access to the Product or to terminate the agreement with the Company immediately and cease to provide any Services to You.

- 4.1. All financial information by the Company is used solely to bill for availing the Product by the User, and is not used for marketing or promotional purposes. Towards this end, We disclose such information to a third-party intermediary, for the sole purpose of payment processing, which is used to make payments for availing the Product.
- 4.2. The individual User's Information may be shared by Company with third party intermediaries to the extent necessary for providing and improving the Services provided to the User. Company may share anonymous aggregate information to third parties in the form of metrics, cumulative data etc.
- 4.3. We may also disclose certain information to third parties solely to help diagnose technical problems, to administer the Website, the Product or the Application, and improve the quality of the Services provided by Us.
- 4.4. We reserve the right to disclose any information as required by law and when we believe, at our sole discretion that disclosure is necessary to protect our rights, protect someone from injury and/or to comply with any law, judicial proceeding, court order, or legal process served on the Company.

## 5. COOKIES

- 5.1. You are encouraged to use the "clear cookers functionality of Your browser to ensure such clearing/ deletion, since it is impossible for Us to guarantee, predict or provide for the behaviour of Your system.
- 5.4. The information We collect with cookies are not sold, rented, or shared with any third parties, other than for internal development and maintenance of the Website, the Product and the Application.
